Residential Opening Terms & Conditions

- 1.) It is the homeowners' responsibility to have the pool water at the appropriate level (midway in the skimmer opening) and excess water/debris removed from cover prior to Advanced Poolcare's arrival. Additional charges, at current labor rates, will be incurred to perform services. Re-Scheduling may be required if water is not at appropriate level or water / debris on cover is excessive.
- 2.) Payment is due upon completion of work. Delinquent payments shall incur a finance charge at the rate of 18% per annum from due date until paid in full. Advanced Poolcare shall be entitled to recover reasonable and customary attorney's fees, filing fees, and any expense incurred to enforce the terms of this Service Contract, including required payments.
- 3.) Advanced Poolcare will not be held responsible for any damage to pool associated with winterization performed by pool owner or any other pool service company. This includes, but is not limited to the pool structure, pool equipment, and underground piping.
- 4.) This opening does not guarantee the clarity of your water. Advanced Poolcare will apply the initial chemical treatment and vacuum one time for appropriate service packages. It is the responsibility of the pool owner to follow up with chemical treatments if necessary to continue to clear the water. Advanced Poolcare can make return visits to chemically treat the water and/or vacuum for additional charge upon customer request.
- 5.) Advanced Poolcare shall not be responsible for any damages to the pool, its deck or other related parts due to hydrostatic (water) pressure should it occur during the emptying of the pool for drain and clean, repair, & liner replacement or while the pool is left empty or filling with municipal/customer water source.
- 6.) All chemicals and accessories used for pool/spa opening must be purchased from Advanced Poolcare.
- 7.) Advanced Poolcare reserves the right to cancel this contract at anytime for any reason.
