**Service Terms & Conditions**

- 1.) It is the homeowners' responsibility to have the pool water at the appropriate level (midway in the skimmer opening) and excess water/debris removed from cover prior to Advanced Poolcare's arrival. Additional charges, at current labor rates, will be incurred to perform services. Re-Scheduling may be required if water / debris is excessive.
- 2.) **Credit Card on file is required for weekly pool/spa service.** Invoices will be generated monthly and charges applied to credit card on the 1st of each service month. Customers will be emailed a paid receipt.
- 3.) Advanced Poolcare will not be held responsible for any damage to pool associated with winterization performed by pool owner or any other pool service company. This includes, but is not limited to the pool structure, pool equipment, and underground piping.
- 5.) Advanced Poolcare shall not be responsible for any damages to the pool, its deck or other related parts due to hydrostatic (water) pressure should it occur during the emptying of the pool for drain and clean, repair, & liner replacement or while the pool is left empty or filling with municipal/customer water source.
- 7.) Advanced Poolcare reserves the right to cancel this contract at anytime for any reason.
